| 1. | The Enable Jersey Raffle is being promoted by Enable Jersey, a registered charity in Jersey, registration number 163. |
| 2. | The Enable Jersey Raffle is regulated by the Jersey Gambling Commission (JGC) Permit number: CP-2698-26 and is required to provide JGC with details of all prize winners. |

| 5. | Only 7,000 tickets will be issued for the Enable Jersey Raffle, numbered from 0001 to 7000. Tickets numbered 0001 to 3,000 will be available as printed copies for in-person sales, while tickets 3,001 to 7,000 will be available for purchase online. |
| 6. | Tickets will be sold at £20 each. |
| 7. | An individual may purchase a maximum of 10 tickets. |
| 8. | All those affiliated with Enable Jersey are permitted to purchase tickets except the Promoter. |
| 9. | Tickets are only eligible for purchase by adults aged 18 years or over on the date of purchase. Age verification for online sales will be managed via Yoti, and for in-person sales photographic ID may be requested where there is doubt regarding age. |
| 10. | Any ticket purchaser found to be under 18 years of age will automatically forfeit the right to claim a prize. The ticket will be voided, the ticket price refunded to the original payment method, and the matter will be reported to the JGC. |
| 11. | All tickets must be purchased within Jersey by individuals who are resident on the island at the time of purchase. |
| 12. | Entry into the Enable Jersey raffle is only valid for tickets that have been paid for in full prior to the draw ticket sale closure on 18:00 on 6th December 2026 unless all tickets are sold before this time. In the event of a sell-out, sales will end immediately. No unsold tickets will be entered into the draw. |
| 13. | Only one name can be entered as the ticket purchaser. The prize will be awarded to that person in accordance with these terms and conditions. |
| 14. | All ticket sales are final and non-transferable and are evidenced by electronic confirmation (online) and handover of physical ticket (in-person) |
| 15. | Tickets are sold to individuals, whose name is recorded at the time of purchase and printed on the ticket or recorded digitally after in-person sales. Only one name will be entered as the ticket purchaser, and any winnings will only be paid to that individual in accordance with these terms and conditions. |

| 17. | All online ticket purchases will be recorded through the Enable Jersey Tickets platform https://raffle.enablejersey.org . A confirmation email will be sent to the purchaser including their ticket number and name, with the option to download and print a receipt. |
| 18. | Both hard copy and digital tickets are valid for entry into the raffle. All ticket sales are final, as confirmed by the issuance of a physical ticket or digital receipt. |
| 19. | The Enable Jersey raffle draw will take place 19:00pm, Thursday 10 th December at Osprey House, Kingsman Offices subject to the terms of clause 20. |
| 20. | Enable Jersey reserves the right to change the venue of the draw but not the date or time. Enable Jersey will communicate any changes to all ticket purchasers of any change to the venue through www.Enablejersey.org , https://raffle.enablejersey.org , social media, local media and the email provided at the time of purchase. |
| 21. | The Enable Raffle will be made by randomly drawing a token from a secure tombola. The ticket numbers will be drawn in consecutive order from 1 st Prize through to 12 th Prize. |
| 22. | All attendees of the draw event will witness the Enable Jersey draw. |
| 23. | Enable Jersey will publish the results of the draw on Enable Jersey website and on social media. Winners will be contacted by Enable Jersey within 24 hours from the draw, all reasonable efforts will be made to contact winners using all available contact details. |
